House of Delegates schedule

The 2016 Interim Meeting of the AMA House of Delegates (HOD) will meet Nov. 12–15 at the Walt Disney World Swan and Dolphin Resort in Orlando, Florida. The AMA-HOD will convene at 2 p.m. Saturday, Nov. 12 in Pacific A–B Ballroom. Your Speakers intend to start promptly at 2 p.m. The Opening Session will conclude no later than 6 p.m. On Sunday, Nov. 13, the "Second Opening" of the AMA-HOD will be in session from 8 to 8:30 a.m. to receive items of business, consider acceptance of late resolutions, and extract informational reports and items from the reaffirmation consent calendar. The following reference committees will convene open hearings from 8:30 a.m. to noon Sunday after the Second Opening (all hearing rooms are in the Dolphin Tower):

As noted in the <u>meeting information memo</u>, advocacy-related medical education issues will be handled in their own reference committee as part of a trial to even out workloads.

The AMA-HOD will reconvene at 2 p.m. Monday, Nov. 14, and 8:30 a.m. Tuesday, Nov. 15. The AMA-HOD will adjourn by noon on Tuesday. Your Speakers ask delegates to schedule departures no earlier than Tuesday afternoon so that they can give full consideration to the business debated that day.

Meeting details and reminders

Handbook distribution

The Handbook will be posted on the Interim Meeting website by October 14. It will be posted as a single large document as well as in a series of smaller documents, collated by reference committee. The Addendum will be posted about October 25. When it is posted, the original Handbook and Addendum will be available separately along with a combined document that interleaves the Addendum with the Handbook. Like all other meeting materials, the Handbook will be posted at <u>ama-assn.org/go/interim2016</u>. An abridged Handbook containing only the recommendations from reports and the resolve clauses from resolutions will also be available as a Word document.

Registration

Registration for the AMA-HOD will be located in the Dolphin Hotel Convention Foyer (Lobby Level). For security purposes, all attendees will be required to provide photo identification at the AMA registration desk in order to receive their credentials and other materials. Registration will open daily at 7 a.m. and run from Friday, Nov. 11 through Tuesday, Nov. 15.

Delegates and alternate delegates should check with their sponsoring society to ensure that their names have been submitted to the Office of House of Delegates Affairs prior to this meeting. AMA bylaws require that all delegates and alternate delegates be properly credentialed before *each* AMA-HOD meeting. Individuals whose credentials have not been confirmed prior to the Interim Meeting will have to be accompanied to the AMA registration desk by an officer of their society in order to register.

Proceedings of AMA meetings may be recorded by audiotape, videotape or otherwise, for use by the AMA. Participation in/attendance at a meeting shall be deemed to confirm the participant's consent to recording and to the AMA's use of such recording.

Opening Session agenda

The Opening Session will get underway at 2 p.m. Saturday, Nov. 12 in the Pacific A–B Ballroom. Included in the Opening Session will be the presentation of various awards, a brief presentation of the modernized *Code of Medical Ethics*, and addresses by AMA President Andrew Gurman, MD, and Executive Vice President James Madara, MD. Concluding the session will be a MACRA Update program. We will conclude by 6 p.m.

House of Delegates MACRA Update

At the close of the House of Delegates Opening Session on Saturday, Nov. 12, our AMA will provide an update on the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA). AMA President Andrew W. Gurman, MD, will moderate the session. AMA Senior Vice President Richard A. Deem will provide an overview of the Final MACRA Rule which is expected in mid- to late-October and will also highlight future MACRA advocacy priorities. AMA Group Vice President Michael A. Tutty, PhD, will showcase AMA tools and resources that the AMA has produced to assist physicians with MACRA implementation at the practice level. The forum will include time for attendees to ask questions related to MACRA.

Childcare options

Zika virus and the Interim Meeting

Your Speakers have been monitoring the situation in Orlando with respect to the Zika virus. While there have been no locally transmitted cases of Zika virus in Orlando or surrounding Orange County, our best advice is that members of the House heed the travel guidelines from the Centers for Disease Control and Prevention. Reports of the Board of Trustees and AMA councils

In accord with past practice, Board and council reports were posted to the 2016 Interim Meeting <u>website</u> for review by all physicians. The reports are posted until the Handbook becomes available, at which time they will be replaced by the electronic version of the Handbook, which contains all items of business—resolutions and reports—along with other information such as the Official Call, hotel maps and the seating chart.

Conflict-of-interest policy

Sponsors of resolutions are reminded that the AMA-HOD has established policy ($\underline{G-600.060}$) calling on delegates introducing an item of business for consideration by the AMA-HOD to declare any commercial or financial conflict of interest at the time the resolution is submitted and that any such conflict of interest be included with the resolution.

Your Speakers have determined that this policy also applies to resolutions introduced by delegations. The sponsoring delegation must disclose the identity of any delegate or alternate delegate who has a commercial or financial interest with respect to matters addressed in the resolution. If a conflict is disclosed, the notation on the resolution will not contain an individual delegate's name, but will state in substance that, "In accordance with House policy regarding disclosure of conflicts of interest, the delegation has notified the Speaker that one or more delegates has a commercial or financial conflict of interest with respect to the matters addressed in this resolution." For resolutions already submitted, please notify the AMA Office of House of Delegates Affairs. A revised resolution containing the conflict-of-interest statement will be distributed.

HOD Reference Manual: Procedures, Policies and Practices

The November 2016 revision of the House of Delegates Reference Manual is now available online at <u>https://assets.ama-assn.org/sub/meeting/documents/hodrefmanual.pdf</u> (login required). This version includes an entirely new chapter on parliamentary procedure, incorporating AMA's new parliamentary authority (*The American Institute of Parliamentarians Standard Code of Parliamentary Procedure*) along with changes adopted by the House. A number of other updates are also included for accuracy and to reflect current practice.

The manual may be especially helpful to new delegates, but it is also a good reference for experienced delegates, Federation staff and other meeting participants. The House will be asked to adopt the updated Reference Manual as the official method of procedure in handling and conducting the business before the AMA-HOD.

The Council on Medical Education will host a Stakeholders' Forum 2:30–4 p.m. Friday, Nov. 11 in Southern Hemisphere 5 at the Dolphin to engage medical education stakeholders in a discussion of the implications of the integration of allopathic and osteopathic GME accreditation.

- What are the traditional differences between allopathic and osteopathic training, and how have these differences been addressed?
- Timeline: where did we begin, and where are we now?
- What are the downstream impacts of a combined accreditation system with respect to the following?
 - > The overall number of training programs/slots available
 - International Medical Graduates
 - > The rapidly increasing number of osteopathic and allopathic medical schools
 - > The implications for board certification
 - > The challenges and appeal of integrating MD and DO trainees and faculty

Dr Sanjana will present "Gene Editing to Decipher Human Genetics." *Zika Virus: What Physicians Need to Know (1.0 AMA PRA Category 1 CreditsTM)

3–4 p.m. Sunday, Nov. 13, Northern Hemisphere A 1–2 at the Dolphin Hosted by the Council on Science and Public Health

Join public health officials from the state and federal levels to hear the latest updates on Zika virus. A mosquito-borne flavivirus transmitted to humans primarily through the bite of an infected Aedes species mosquito, Zika is the first mosquito-borne virus associated with human birth defects or capable of sexual transmission. As public health officials learn more about the virus, clinical guidance continues to be updated. It is critical for physicians to be aware of the symptoms of Zika virus and to work with their state and local health departments to facilitate diagnostic laboratory testing. With local-transmission of Zika virus confirmed in South Florida, the Centers for Disease Control and Prevention has issued its first travel advisory for a city (Miami) in the continental United States. This educational session will provide an update on the epidemiological aspects of the current outbreak, describe efforts by public health agencies to prevent transmission, and explain the latest guidance for physician and their patients.

*Physician Aid in Dying (2.0 AMA PRA Category 1 CreditsTM)

This session will explore the ethical implications of physician aid in dying. The Massachusetts Medical Society will recount how the Massachusetts Board of Medicine suspended the medical license of a Massachusetts physician for more than three years without allowing the physician an opportunity to defend himself–and what organized medicine did to assist this physician. Updates will be provided on the lawsuits opposing the Anthem/Cigna and Aetna/Humana health insurance company mergers as well as the case challenging the Florida law limiting physician communications with their patients regarding possession of firearms

Human Trafficking

8–9:30 a.m. Monday, Nov. 14, Northern Hemisphere E 3–4 at the Dolphin Hosted by the American College of Obstetricians and Gynecologists

In 2011, an American College of Obstetricians and Gynecologists (ACOG) Committee Opinion noted: "Barriers to accurately assess the scope of [human trafficking] include the hidden nature of the problem, fear and cultural barriers, lack of awareness on the part of the public and public officials, the limited legal language related specifically to human trafficking, and the lack of adequate funding and training for those capable of identifying and assisting victims of human trafficking." Providers across all disciplines may encounter trafficked individuals and this program will help provide strategies and tools to empower physicians to help survivors. A 2014 *Annals of Health Law* study found that nearly 88% of trafficking survivors had reported an encounter with a healthcare system *while they were being exploited*. The study revealed providers are "woefully unprepared" to identify victims of human trafficking.

In this workshop, you will hear from three speakers, two of whom are survivors: Connie Rose with Selah Freedom and Connie Rose Consulting, Erin Tracy, MD, with ACOG, and Holly Austin Gibbs with Dignity Health. The speakers will explain dynamics of human trafficking, medical red flags, and strategies to implement response protocols in healthcare systems.
